CONFLICT OF INTEREST CHECKLIST FOR REVIEWERS OF DISSERTATIONS AND THESIS

Before agreeing to serve as a reviewer for a master's thesis or doctoral dissertation, please review the list of questions below to determine whether there are any conflicts of interest that could be perceived as detrimental to your review. If your answer to any of these questions is "yes", you probably have a conflict of interest and should decline the invitation, or check the potential or apparent conflict of interest box and complete the paragraph to explain how this conflict has no real impact on your application.

All evaluators, except the research director and co-directors

- Have you co-authored or conducted research in direct collaboration with the student in the last five years?
- Have you co-authored or had a research collaboration with the supervisor and/or co-director of research on a topic directly related to the dissertation or thesis in the last five years?
- In the past five years, have you been evaluated or been evaluated by the student's supervisor and/or co-supervisor (ex.: if you are the supervisor's former student or research supervisor student research)?
- Do you have a significant emotional or financial connection with the student or research supervisor?
Example:
 - A past or present spouse.
 - A close family member.
 - A past or present business partner.
- Do you knowingly have a financial interest in an entity that could benefit from the research project of the dissertation or thesis?
- Have you entered into (or intend to enter into) negotiations with the student or research supervisor relating to future employment or supervision?
- Have you engaged in any other activity that could be perceived as a conflict of interest or that could affect your impartiality?

External examiner only (doctoral theses)

- Have you had, in the last five years, or do you currently have an affiliation (including as a student) with the student's academic unit²?
- Have you held a university position (visiting professor, for example) at the University of Montréal (including Polytechnique and HEC) in the last five years?
- Have you already read the thesis, in whole or in part, before submitting it?
